

## Data Protection Notice

This data protection notice sets out details of the personal data that we collect from you, or which you provide to us, when you visit our website or contact us. It also sets out details of how we process that personal data, who we disclose it to, and your rights in connection with our processing of your personal data.

### Personal Data that We Process

We process the following personal data about you:

- Accounts/email updates - If you register to receive email updates, or create an account with our website, we will collect your name, email address, country, occupation and your communications preferences.
- Information that is automatically collected - We use certain technologies that collect non-personally identifiable details about how our website is used, such as what pages you visit and how long you stay on them. ### Purposes of Processing and Legal Basis

- Accounts/email updates - We process your personal data in order to provide you with email updates and to allow you to log-in to your account to change your preferences. We process this data on the basis of our legitimate interests in making the account and email update feature available.
- Information that is automatically collected - We process this personal data to help us understand how our website is being used and to help us make improvements to our website. To the extent that this involves the processing of personal data, it will be on the basis of our legitimate interests in making the website available and improving its services.

### Recipients of Data

We may disclose your personal data to various recipients in connection with the above purposes, including:

- Service providers - Our website is operated by a third party service provider, who makes the website and its features available on our behalf. We also use other service providers in the context of operating our business, some of which may have access to your personal data in the context of providing those services.
- Purchasers of our business - We may disclose the personal data collected pursuant to this notice to third parties to whom we may choose to sell, transfer, or merge parts of our business or our assets.

## Retention

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements.

## Your Rights

You have the following rights, in certain circumstances, in relation to your personal data:

- *Right to access the data* - You have the right to request a copy of the personal data that we hold about you, together with other information about our processing of that personal data.
- *Right to rectification* - You have the right to request that any inaccurate data that is held about you is corrected, or if we have incomplete information you may request that we update the information such that it is complete.
- *Right to erasure* - You have the right to request us to delete personal data that we hold about you. This is sometimes referred to as the right to be forgotten.
- *Right to restriction of processing or to object to processing* - You have the right to request that we no longer process your personal data for particular purposes, or to object to our processing of your personal data for particular purposes.
